## Rules and Regulations:

Even if you have participated in the past, you must complete an application for 2011 First Fridays are intended to help promote local businesses. We welcome producer-made (handmade) art only.

You may sign up for an artist vendor table on a per month basis, or purchase a season pass. Per month spots are available for $\$ 45.00$ per month on a first pay, first serve basis. You may sign up at beginning of year for all months you wish to participate in, and pay monthly, as long as the payment is received no later than the Friday prior to First Friday. You will be notified immediately if you wish to participate and all spots are full, any payment already made for that month will be returned. If your payment is not received on time, your spot will be released for another artist.

A season pass will ensure you a spot every month May - Sept for $\$ 180.00$, but there are no refunds for months that you do not participate in and the spot location is not stationary and will be placed month to month. As a season pass holder you must cancel any month that you are not participating. If you are a "no show" more than twice without notice, your spot will be released. A limited amount of season passes are available.

Acceptance of application is subject to approval by the Phoenixville's First Friday Committee and is based on appropriateness of product and space available. Artists will receive a First Friday vendor permit; this permit must be printed and displayed somewhere visible on your booth at each event you attend.

Food products and reselling are not permitted through the Artist Vendor permit.
Artist Vendor Permit provides a 10x10 space only, all tents, tables, extension cords etc are all provided by artist. Please note that we will do our best to make electricity available if requested, but it is not guaranteed. 2011 Artist Vendor Application.
